#### 1. Target person

(1) Persons with a status of residence of "Student" (International Student)

Not applicable to (2) and (1), recommended by the school established by this corporation, and Either "family stay", "Japanese spouse, etc." or "settlement"

Person with status of residence

# 2. Reduction and exemption amount

[Normal time]

490,000 yen per year (only for undergraduate students)

[Leave school due to military service]

Because the person eligible for the exemption will be in military service according to the laws and policies of the country in which he / she has a nationality

If you take a leave of absence, the facility maintenance fee will be exempted.

Facility maintenance fee 200,000 yen per year (100,000 yen for half a year) (for undergraduate and graduate students)

### 3. Exemption period

(Normal time)

Up to 4 years (undergraduate student)

[Leave school due to military service]

Period of military service

#### 4. Cancellation conditions

- (1) When the prescribed procedure is not performed
- (2) If you receive disciplinary action
- (3) When GPA falls below 1.0 for two consecutive terms for half a year due to poor academic performance
- (4) If you repeat a year (except if you repeat a year due to a leave of absence due to unavoidable reasons)
- (5) When a person eligible for exemption offers to decline
- (6) The number of attendance hours is less than two-thirds of the total number of class hours for the subject without a justifiable reason.

When there are more than one-third of the total number of courses taken in the semester for which credits cannot be given

(7) When it is recognized that the order of the university has been disturbed and that it is significantly contrary to the student's duties.

# 【兵役による休学】

減免対象者が国籍を有する国の法律や政策により兵役に就くことを理由として、 休学する場合は、施設維持費が減免される。

施設維持費 年額 200,000 円(半期 100,000 円)(学部生・大学院生対象)

最大 4 年間(学部生)

#### 4.取消条件

- (1)所定の手続きを行わない場合
- (2)懲戒を受けた場合
- (3) 学業成績不振で半期の期間 GPA が 2 期連続して 1.0 を下回った場合
- (4) 留年した場合(やむを得ない理由による休学で留年した場合は除く)
- (5)減免対象者が辞退を申し出た場合
- (6)正当な理由なく、出席時間数がその科目の総授業時間数の3分の2に満たず 単位を与えられない科目が当該学期の総履修科目数の3分の1以上ある場合
- (7)本学の秩序を乱し、その他学生としての本分に著しく反したと認められた場合
